## **NOTIFICATION NO. 134 OF 2025**

It is hereby notified for the general information that Bar Council of India in BCI Tr. Case No.467 of 2022 passed an Order dated 15/10/2023 whereby **MR. RAM AWADH SHIVSHANKAR PANDEY, ADVOCATE (MAH/5567/2007)** residing at 002/5, New Star Crystal, Near Kanakia Police Station, Mira Road (E), THANE 401 107 & **MR. KAMLESH KUMAR BRIJMOHAN MISHRA, ADVOCATE (MAH/407/2010)** residing at A-302, Sangam Plaza, Ramdev Park Road, Mira Road (E), Taluka: Vasai, Dist: PALGHAR 401 105 **HAVE BEEN SUSPENDED FOR A PERIOD OF 5 (FIVE) YEARS as Advocates** from the Roll of the Bar Council of Maharashtra and Goa under section 35(3)(c) of the Advocates Act, 1961 on account of professional misconduct, and they are thus hereby debarred from appearing and practicing in any Court of Law.

**RESPONDENTS ARE FURTHER DIRECTED TO PAY RS.2,88,500/- which is taken on account of Court Fees to the Complainant alongwith Rs.50,000/- for cost of this Complaint to be paid to the Complainant jointly or severally within 4 weeks. Failing which, their License will be further suspended for a period of 2 Years.**

**RESPONDENTS ARE FURTHER DIRECTED TO DEPOSIT RS.25,000/- to the Welfare Fund of the Bar Council of Maharashtra & Goa.**

As per this order, they cannot practice before any Court, Authority or Tribunal in India henceforth.

Accordingly, an entry to that effect is taken on the Roll of this Council.
