NOTIFICATION NO.3131 OF 2025


It is hereby notified for the general information that Bar Council of India in BCI Tr. Case No.792 of 2022 passed an Order dated 21/01/2024 whereby the Respondent Advocate **MR. NEVIL ARDAVIRAF ZAVERI** bearing MAH/441/2012 having his Address at G-Type Bldg., Flat No.10, 2nd Floor, Shapporji Bharucha Baug, S. V. Road, Andheri (W), MUMBAI 400 058 **HAS BEEN IMPOSED A FINE OF RS.25,000/- TO BE DEPOSITED IN THE WELFARE FUND OF THE BAR COUNCIL OF INDIA AND RS.50,000/- AS A COMPENSATION TO BE DEPOSITED WITH THE COMPLAINANT WITHIN PERIOD OF 15 DAYS FROM 18/11/2025 FAILING WHICH, THE LICENSE OF THE RESPONDENT ADVOCATE WOULD BE SUSPENDED FOR A PERIOD OF ONE YEAR. BUT TILL DATE AS PER OUR RECORD, YOU HAVE NOT COMPLIED WITH THE DIRECTION OF BAR COUNCIL OF INDIA DATED 21/01/2024. HENCE, YOU HAVE BEEN DEBARRED FOR A PERIOD OF 1 (ONE) YEAR as an advocate** from the Roll of the Bar Council of Maharashtra and Goa under section 35(3)(c) of the Advocates Act, 1961 from the date of this Notification, on account of professional misconduct, and he is thus debarred from appearing and practicing in any Court of Law.

It is further notified that non-compliance of the order of Bar Council of India, Secretary Bar Council of Maharashtra & Goa is directed to initiate the publication proceedings.

As per this order, he cannot practice before any Court, Authority or Tribunal in India henceforth.

Accordingly, an entry to that effect is taken on the Roll of this Council.
