It is hereby informed to all Advocates in the States of Maharashtra, Goa and Dadra & Nagar Haveli and Daman & Diu that, vide Resolution No.204/2025 dated 28.12.2025, the Bar Council of Maharashtra & Goa has extended the **final date** for submission of Verification and Declaration Forms till **05.01.2026**.

If the verification and declaration form has been already submitted in the year **2024-2025**, **there is no need to resubmit** the same.

However, all advocates are requested to check whether there is any discrepancy in name, address or other details by visiting below mentioned link which will be active from 31.12.2025 at 2.00 p.m. till 05.01.2026 at 12.00 midnight on <https://barcouncilmahgoa.org/services>. Online application for Verification / Declarations may be submitted on this link alongwith necessary payment and documents.

This is the **final opportunity** for submission of the Verification and Declaration Form.

Who will be included in the Voter List:-

- **Advocates enrolled prior to 31.12.1989**

For This Category, there is no need to submit any Verification form as a mandatory requirement for inclusion in voter list. Therefore, all such enrolled advocates will be included in voter list.

- **Advocates enrolled between 01.01.1990 to 31.12.2018**

For this category there is requirement of submission of verification form otherwise the names will not be included in voter list.

- **Advocates enrolled between 01.01.2019 to 31.12.2020**

For this category an advocate who has submitted the declaration form in the year 2024-2025, their names will be included in the voter list. However, after completing 5 years practice the advocates will be required to comply the verification process in due course.

- **Advocates enrolled between 01.01.2021 to 31.12.2023**

An advocate from this category are required to file their declaration form and also clear AIBE exam. Advocates making both these clearance will be included in the voter list.

- **Advocates enrolled between 01.01.2024 to 31.12.2025**

In this category undertaking regarding clearance of AIBE in 2 years from date of enrolment is only requirements alongwith filing of declaration.

NOTE:-

- The advocates who have file declaration after 2024 in verification process will not required to re-submit the declaration for inclusion of their names in the voter list.
- List are under preparation on above basis as per the direction of Bar Council of India and orders of Hon'ble Court. After publication of list 15 days' time will be given for objection and clearance.
- This voter list will be finalised as per the final direction received from the High Power Committee appointed by the Supreme Court for supervision of election.
